MINUTES

WVRA Meeting July 22, 2023, Beverly, WV

The meeting was called to order at 4:00 p.m. by Vice President, Art Dodds, in the absence of President Andrew Valentine. Present at the meeting were Art Dodds, Pam Dodds, Chuck Critchfield, Tim Glaser, John Arnold, Keith Kopshina, Bill Brisendine, Dave and Sue Judy, Jack and Debbie Rush, Jim and Linda Barnes, and Phyllis Baxter.

The Secretary's report was published in the most recent newsletter. Dave Judy moved to accept the Secretary's report, seconded by Jack Rush, and approved.

The Treasurer, Rick Byrd, was unable to be present but had provided the Treasurer's report by email. Chuck Critchfield provided that the Treasurer reported our funds are currently \$1511.68. Dave Judy moved to accept the Treasurer's report, seconded by Jack Rush, and approved.

Chuck Critchfield provided a newsletter report, summarizing that there are 6 to 7 new members, but that about 15 members still have not renewed their membership. We currently have 50 members providing membership dues almost sufficient to pay for insurance. It was recognized that numerous groups have suffered lower membership and funding.

There was a group discussion concerning the policy that insurance is more important than individual funding of reenactors (\$100 per person). Everyone concurred that funding would be available after the cost of insurance was covered.

Chuck Critchfield reported that the *Clarksburg Historical Society* is planning bus tours that will bring visitors to Clarksburg to observe an approximate 15-minute presentation of Senator John Carlile speaking to a crowd in 1861. Rick Wolfe has offered to portray Senator Carlile. Civilian reenactors

have been requested for this event. Chuck Critchfield will be providing the event contact information to Pam Dodds, TASAS Representative, to discuss possibilities of WVRA providing civilian reenactors.

John Arnold inquired if there is any interest in a living history event at Corrick's Ford. Roger Ware has discussed this potential event with John Arnold. John asked for anyone interested in this event to contact him. Dave Judy provided that the reenactment schedule for the next year is usually finalized in November, so plans for an event at Corrick's Ford should be established relatively soon.

Chuck Critchfield reminded the members that we have had difficulties filling the officers' positions and encouraged us to all be thinking about who will be willing to serve as an officer.

Dave Judy moved to adjourn and all approved and the meeting adjourned at 4:25 p.m. Respectfully Submitted,

Correction - Apology

I wanted to issue a correction or maybe just a clarification to something I said at the July meeting. At worst, I was wrong and at best it was just misleading. I misspoke about the memberships and costs.

As of July 23, 2023, we had 51 members in the WVRA. But we only had 34 memberships. Members don't pay dues. Memberships pay dues. You may wonder what in the blue blazes is he talking about? Here is what I mean. We have memberships with multiple members. For instance, my wife and I pay a family membership. That's two members, but one membership or \$25. We have families of five members who pay a family membership of \$25. So we have 51 members in 34 dues-paying memberships on July 23 with an average membership of \$17.21 (total dues/# memberships).

The insurance policy this year was \$715.98. Our dues are \$130 short. Nine individual memberships or six family memberships additional would cover the insurance.

Also we had over \$250 in additional costs (unit monies, internet fees or mailing costs). That would put our 2023 shortfall around \$400 to date.

I apologize for being off on my calculations. I had forgotten that to be eligible for insurance we had to also purchase a group membership in the NRA, which was another \$40.
