Just before Christmas, I got an unusual request for a living history presentation. A local Monongalia County reenactor, Tyler Claypole, formerly a member of the Barbour Grays, approached me and asked if I would give a presentation about WWII at a young fellow's birthday party. It seems that Tyler's employer's 8 year-old son, Ben, is a history buff with a strong interest in WWII, especially the Battle of the Bulge. They asked if I could come out in period attire and maybe fire off a round or two and discuss the battle.

I agreed to do so, noting that I didn't have an appropriate American firearm that I could use, but would they mind if I came as a German. There were no objections, so I agreed to do so.

On January 2nd, I met Tyler (who came in Civil War garb to give a presentation on that period) and we proceeded to his employer's home. The family lives out in the country, so I didn't have to worry about making any noise.

As it turned out, I had a great time. The family was very friendly and welcoming and expressed a great deal of appreciation for the visit. The father is an Iraq War veteran and is very interested in military history himself. The birthday boy was knowledgeable about the war and the battle and asked excellent questions. With his dad's permission, I let him fire a blank through the Mauser. The lady of the house had prepared an excellent meal using WWII era recipes to show their appreciation.

A Mistaken Mistress

The Wheeling Daily Intelligencer reported on the proceedings of a court martial trial at Charleston in which Captain William A. West (Co. I, 1st West Virginia Cavalry) was discharged from Union service. Among the charges against him was "keeping his wife in camp, dressed in the uniform of a soldier." The newspaper printed a retraction on May 13, 1862: "We are requested to state that this is a mistake--it was another man's wife that West had in camp, and not his own. We make the correction with pleasure."

And should he be nervous, which is not always the sign of a bad soldier, he may imagine objects in front of him (such as bushes, tufts of grass, etc.) moving., and are people, and then the noise of the wind through the forest trees, or the falling of leaves he may fancy to be the sound of marching coming towards him, so he tries to steady his nerves and keep cool. Then these visions vanish for a while only to be renewed again in some other form."

THE MOVIE 1917 got a lot of attention when it was released in 2019. I just re-watched the 9 minute opening sequence which is one long unedited take. Quite a feat in movie making. But what really intrigues me is the movie set - or the background.

The sets and the costumes are what makes this movie stand out to me. The story line is not that outstanding. The actors are fine. But the landscape, uniforms, and trenches transport the viewer to a different experience.

This leads to another movie I recently had a discussion about - The Man Who Shot Liberty Valance which has a very fine story line and wonderful actors. But the sets are cheesy and take away from the overall experience. This movie resembles a stage play that was converted to a movie.

I will never forget my original reaction to the opening shot in 1917. The two soldiers, fully equipped lounging behind the line in a green field absolutely no evidence of war or any disturbance to the natural environment. Everything close to the lines in 1917 was mud and dirt. Low-lying northern France was wet all the time. But then the soldiers, awakened to action by a sergeant, slowly stroll towards the front line and the background goes progressively from a green field, to mud and chaos of the front line trench. What a transition. I loved it.
