## 155 Years Ago

With the report on the incident at Cedar Creek taking priority this issue, this feature will be delayed until

next issue when I will resume my report on the actions of the 1st West Virginia and 12th West Virginia in 1862. As always, I welcome any similar information on the 25th Virginia or 1st Virginia Cavalry.

They Said It
"Negroes are to this country what raw materials are to another country." Charles Cotesworth Pinckney, aide to George Washington, delegate to the Constitutional Convention and Charleston Planter.

"Ah! Slavery is a hard business, and I am afraid that in this country we shall know it to our bitter cost some day or other." Written by a Charleston woman a few days after the Denmark Vesey rebellion mass hangings in Charleston, South Carolina.

"I would save the Union. I would save it the shortest way under the Constitution. The sooner the national authority can be restored the nearer the Union will be "the Union as it was." If there be those who would not save the Union unless they could at the same time save Slavery, I do not agree with them. If there be those who would not save the Union unless they could at the same time destroy Slavery, I do not agree with them. My paramount object in this struggle is to save the Union, and is not either to save or destroy Slavery. If I could save the Union without freeing any slave, I would do it, and if I could save it by freeing all the slaves, I would do it, and if I could save it by freeing some and leaving others alone, I would also do that. What I do about Slavery and the colored race, I do because I believe it helps to save this Union, and what I forbear, I forbear because I do not believe it would help to save the Union. I shall do less whenever I shall believe what I am doing hurts the cause, and I shall do more whenever I shall believe doing more will help the cause. I shall try to correct errors when shown to be errors; and I shall adopt new views so fast as they shall appear to be true views. I have here stated my purpose according to my view of official duty, and I intend no modification of my oftexpressed personal wish that all men, everywhere, could be free."

# Don't Bring a Knife to a Gun Fight

While on vacation at a southern North Caroline beach, Diane and I visited the National Park Battlefield at Moores Creek Bridge, located approximately 40 miles northwest of Wilmington, North Carolina.

In the early days of the Revolution approximately 1,500 Scotch highlanders, recent immigrants to colonial America and loyal to King George attempted to march from east central North Carolina to near Wilmington in an effort to join up with British naval and other Tories located along the coast. Led by officers McDonald, McLeod and Campbell, names rich in Scottish lore, the 1,500 men headed toward the Wilmington area.

American militia led by colonels Moore, Lilington and Caswell tried to anticipate their of march by blocking roads and bridges in the area. Caswell and Lillington built some low breastworks and planted two cannons and 950 men on the southern bank of Moore's Creek blocking the road leading from the gridge. The narrow bridge in the midst of a swamp spanned the 50-foot-wide creek that was five feet deep with a tidal variation of 3 feet and with a muddy, miry bottom. However the bridge itself set on a sandbar, which was the highest elevation in the surrounding swamp.

The American militia had removed over half of the planking and had even creased the log stringers with tallow. While waiting behind their breastworks on the early morning of February 28, 1776, they heard the Scotch Tories battle cry "King George and the Broadswords," followed by the shrill notes of bagpipes. Unfortunately for the Tories, they only had around 500 guns to arm their 1,500-man army and had decided to send their shock troops


dressed in kilts and tartans and armed mostly with broadswords and Scottish claymores in a charge across the bridge.

Don't bring a knife to a gun fight, even if it is a big knife. Tory officers McLeod and Campbell were killed at the American's first fire of rifles, muskets and cannons along with approximately 30-40 other Highlanders. McLeod's body had nine-round ball bullet holes along with 24 swan shot.

The Scotch quickly lost courage on seeing their leaders killed and fled the battlefield. Approximately 900 Tories were later capture and disarmed. Only one American, John Grady of Anson's Company was mortally wounded. The early victory probably led North Carolina to instruct her delegates to vote for independence on April 12, 1776 in Philadelphia.

If you are like me, I knew little of the US Army's fighting in North Africa other than Kasserine Pass. But this book describes in some detail the entire campaign , the leaders who tried guide the Army and their British counterparts.

This is a well balanced narrative of the fighting, the strategy and the politics of the Allied effort to defeat the Germans and Italians.

Atkinson does a good job of mixing in individuals involved in the fighting from the soldier driving the tank all the way up to Eisenhower. He is pretty objective, in my opinion, as he doesn't hesitate to criticize as well as praise. The perfect example is his treatment of Patton, who some folks seem to think won the North African campaign by himself. Atkinson praises and shows his shortcomings as well.

This was a quick read for me, and I would recommend to anyone interested in the US Army's role in North Africa. I am looking forward to reading the next volumes of Atkinson's Liberation Triology.
